Code of Conduct Agreement

I realize that confrontations are not allowed. If any sort of conflict arises, physical or verbal, I will remove myself from the situation and not get involved. I realize that I could be prohibited from play in the game and/or the league, if I am involved in such an altercation. This league is run and directed by the Phoenix Hellraisers leadership committee, captains, coaches, its volunteers, and the code of conduct committee, consisting of two members in good standing and one member of the leadership committee. The school or field where the game is played has no responsibility in anything that happens on or off the field.

I realize that I may be suspended from league play if I engage in unsportsmanlike acts, or gross rule violations. Even though I might have paid for an event or tournament, suspensions will carry no refund. I agree to uphold any decision mandated by the code of conduct committee. If I have a dispute, I will submit it in writing to the code of conduct committee for review. I will respect the authority of the officials and coaches working in this league. In the event of a dispute of an interpretation, their interpretation of the event is paramount. Player input will only be accepted if there is a video of the disputed call, and it clearly shows the event.

Each player is responsible for conduct of their teammates. When recruiting, each player must assure that they can vouch for that player. Each teammate must assure that all players on their team have read the rules, and have signed at minimum the code of conduct agreement (this document) and the injury release and risk form before playing in a game or practice. I realize that a hotheaded player may jeopardize my team, and could result in possible team suspension if violence occurs depending on the ruling of the code of conduct committee.
